



VOLUNTEER WAIVER, RELEASE OF LIABILITY, & ASSUMPTION OF RISK

MINOR VOLUNTEER

In consideration of MINOR VOLUNTEER being allowed to participate in the BELLRINGER bicycling tour and any related events, activities and training rides (collectively "BELLRINGER"), I, the undersigned, on behalf of myself and MINOR VOLUNTEER, waive and release the RELEASEES (as defined below) from any and all claims, liabilities, or causes of action arising out of an injury to MINOR VOLUNTEER and from any and all claims, liabilities, or causes of action arising from MINOR VOLUNTEER's participation or attendance in BELLRINGER, and, on behalf of myself and MINOR VOLUNTEER, understand, acknowledge, appreciate, and agree that:

1. I am at least 18 years old and I am the parent or legal guardian of the MINOR VOLUNTEER and I have the legal authority to enter into this VOLUNTEER WAIVER, RELEASE OF LIABILITY, & ASSUMPTION OF RISK on MINOR VOLUNTEER's behalf and I agree that the terms of this VOLUNTEER WAIVER, RELEASE OF LIABILITY, & ASSUMPTION OF RISK shall apply equally to the MINOR VOLUNTEER.
2. MINOR VOLUNTEER will be 14 years of age or older by the date of their participation in BELLRINGER as a MINOR VOLUNTEER.
3. While volunteering for BELLRINGER, MINOR VOLUNTEER will be using public streets and/or working at facilities where many hazards exist. I understand that physical activity and the use of public streets and facilities, by their very nature, carries with them certain inherent risks. I acknowledge that MINOR VOLUNTEER may incur minor injuries, major injuries, and catastrophic injuries, and may be exposed to communicable diseases. The risk of injury from participation as a volunteer in BELLRINGER is significant, including the potential for dehydration, serious injury, and death, and while particular rules, safety initiatives, equipment, and personal discipline may reduce this risk, the risk of serious injury does exist. I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, associated with MINOR VOLUNTEER's participation in BELLRINGER, EVEN IF SUCH RISKS ARISE FROM THE INTENTIONAL OR NEGLIGENT CONDUCT OF THE RELEASEES, and whether or not such risks are covered by MINOR VOLUNTEER's personal health insurance or any other types of insurance, and, understanding such risks, I voluntarily desire MINOR VOLUNTEER to volunteer for BELLRINGER and I assume full responsibility for MINOR VOLUNTEER's participation as a volunteer for BELLRINGER.

4. I acknowledge and agree that I, and I alone, am solely responsible for the personal property MINOR VOLUNTEER brings with them. I assume all risk for any and all activities that MINOR VOLUNTEER engages in throughout the entirety of BELLRINGER, including MINOR VOLUNTEER's safety from the beginning of the event to the conclusion of the event. I agree that the RELEASEES are not responsible for any personal items or property lost or stolen before, during, or after BELLRINGER.

5. I agree that MINOR VOLUNTEER is physically capable of participating as a volunteer in BELLRINGER. If MINOR VOLUNTEER is under treatment for any physical infirmity, ailment, or illness, I will obtain MINOR VOLUNTEER's medical care provider's approval prior to MINOR VOLUNTEER volunteering for BELLRINGER. I further understand that I may be asked to provide a doctor's note or other proof that MINOR VOLUNTEER's primary health care provider has permitted MINOR VOLUNTEER to volunteer for BELLRINGER.

6. I consent to treatment of MINOR VOLUNTEER in the event of an emergency or other incident in which, in the reasonable judgment of the on-site personnel, MINOR VOLUNTEER requires medical care. This VOLUNTEER WAIVER, RELEASE OF LIABILITY, & ASSUMPTION OF RISK extends to any liability arising out of or in any way connected with the medical treatment and transportation provided in the event of an emergency, including, but not limited to, negligent emergency rescue operations.

7. I willingly agree to read and require MINOR VOLUNTEER to read all of BELLRINGER's rules of participation and all safety materials provided by BELLRINGER, including specifically all of the information included in the Event Handbook and all related materials.

8. At all times while volunteering for BELLRINGER, I willingly agree to require MINOR VOLUNTEER to abide by all rules and regulations established by the BELLRINGER organizers, staff, and support personnel, as well as all traffic laws and regulations.

9. I willingly agree to require MINOR VOLUNTEER to comply with the stated and customary terms and conditions for volunteering for BELLRINGER. If, however, I observe any unusual significant hazard during MINOR VOLUNTEER's presence at or participation as a volunteer in BELLRINGER, I will remove MINOR VOLUNTEER from participation and bring such to the attention of the nearest official immediately.

10. I, on behalf of myself, MINOR VOLUNTEER, and my heirs, assigns, personal representatives, administrators, estate, and next of kin, HEREBY VOLUNTARILY, IRREVOCABLY, AND FOREVER RELEASE Georgetown University, Cadence Sports, LLC, and their respective affiliates, officers, officials, agents, directors, advisors, consultants, contractors, representatives, students, and employees, as applicable, (collectively, "RELEASEES"), FROM ANY AND ALL LIABILITY WHATSOEVER, INCLUDING WITHOUT LIMITATION, LIABILITY FOR ANY AND ALL INJURIES, DISABILITIES, DEATH, LOSSES, OR DAMAGES TO

PERSON OR PROPERTY, ARISING DIRECTLY OR INDIRECTLY IN CONNECTION WITH MINOR VOLUNTEER'S PARTICIPATION AS A VOLUNTEER IN BELLRINGER, WHETHER OR NOT CAUSED BY THE INTENTIONAL CONDUCT, ACTIVE OR PASSIVE NEGLIGENCE, OR OTHER FAULT OF THE RELEASEES OR OTHERWISE, to the fullest extent permitted by law.

11. On behalf of myself and MINOR VOLUNTEER, I understand this VOLUNTEER WAIVER, RELEASE OF LIABILITY, & ASSUMPTION OF RISK inures to the express benefit of the RELEASEES and may be relied upon and enforced by any RELEASEE. I also understand that the effectiveness of this VOLUNTEER WAIVER, RELEASE OF LIABILITY, & ASSUMPTION OF RISK shall indefinitely survive MINOR VOLUNTEER's participation as a volunteer in BELLRINGER.

12. I consent to receive emails, phone calls, or SMS messages from BELLRINGER with updates and critical information about the Ride. BELLRINGER will use the contact information provided at registration and updated in my participant profile.

12. I understand that BELLRINGER will be documented by professional and volunteer photographers and videographers. On behalf of myself and MINOR VOLUNTEER, I understand and agree that MINOR VOLUNTEER's name, photograph, voice, or likeness may be used by the RELEASEES for informational, educational, promotional, and/or publicity purposes, among others, including but not limited to use on websites or in publications, displays, newspapers, magazines, advertisements, reports, videotapes, audiotapes, and other media. I hereby grant full permission to the RELEASEES to use, reuse, reproduce, publish, or republish and photographs, recordings, or any other record of MINOR VOLUNTEER's participation in this event, in any medium, alone or in conjunction with other material, without restriction as to changes or alterations. I consent to and authorize, in advance, all such uses and waive all rights of privacy I have in connection therewith. I further understand that I will not be compensated for any such use. I also agree to release the RELEASEES from any and all liability arising out of or connected to the use of MINOR VOLUNTEER's name, photograph, voice, or likeness as stated above. Further, I relinquish all rights, title, and interest in any and all photographs, motion pictures, recordings, or other records of BELLRINGER that I take or capture to the RELEASEES.

I HAVE CAREFULLY READ THIS VOLUNTEER WAIVER, RELEASE OF LIABILITY, & ASSUMPTION OF RISK. ON BEHALF OF MYSELF AND MINOR VOLUNTEER, I FULLY UNDERSTAND THE TERMS OF THIS VOLUNTEER WAIVER, RELEASE OF LIABILITY, & ASSUMPTION OF RISK. I AM AWARE THAT BY SIGNING THIS VOLUNTEER WAIVER, RELEASE OF LIABILITY, & ASSUMPTION OF RISK OR BY SELECTING THE "I ACCEPT" BUTTON DURING THE ONLINE REGISTRATION PROCESS, I AM AGREEING TO ALL OF THE TERMS OF THIS VOLUNTEER WAIVER, RELEASE OF LIABILITY, & ASSUMPTION OF RISK. ON BEHALF OF MYSELF AND MINOR VOLUNTEER, I AGREE TO THIS VOLUNTEER WAIVER, RELEASE OF LIABILITY, & ASSUMPTION OF RISK IN ITS ENTIRETY FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT.
