BELLRINGER FUNDRAISING AGREEMENT & CANCELLATION POLICY

AGE 18 AND OVER

Big goals require big commitments. Ending cancer is going to require enormous amounts of effort and dedication. We've designed BellRinger's fundraising commitments to be challenging yet attainable, and we believe in everyone's ability to fundraise when they set their mind to it. In fact, many Riders and Virtual Riders will raise more than their minimum commitment. We'll be here to help you meet and exceed expectations by providing fundraising ideas and resources all year round. You can access these resources in your Rider or Virtual Rider Dashboard.

In consideration of the acceptance of my registration to participate as a Rider or Virtual Rider in BellRinger, I agree to satisfy the total amount of the minimum fundraising commitment for the particular route or participation option for which I am registered as of 11:59 p.m. on Thursday, September 21, 2023, unless I voluntarily increase my minimum fundraising commitment after that date. Moreover, if I register as a Rider or Virtual Rider after 11:59 p.m. on Thursday, September 21, 2023, I agree that I am irrevocably obligated to satisfy the total amount of the minimum fundraising commitment applicable to my route and fundraising commitment selection unless I voluntarily increase my minimum fundraising commitment. The minimum fundraising commitments are as follows:

- \$1,500 for the 100-mile ride
- \$1,250 for the 50-mile ride
- \$1,000 for the 25-mile ride
- \$500 for Virtual Riders
- \$5,000 for Royal Ringers regardless of route choice or participation option

I further agree that if I elect to become a Royal Ringer, my minimum fundraising commitment is \$5,000 and supersedes the commitment associated with my route distance or Virtual Rider minimum fundraising commitment. I further agree that I will be personally responsible to BellRinger for any shortfall in my minimum fundraising commitment if I fail to satisfy the total amount of my minimum fundraising commitment by the fundraising deadline, which is 11:59 p.m. on Thursday, December 21, 2023.

I agree that, if there is an outstanding balance still due in order for me to satisfy my minimum fundraising commitment after the fundraising deadline has passed, BellRinger reserves the right to charge the outstanding balance to the credit card that I have voluntarily placed on file. I further agree that I will not dispute or otherwise attempt to cancel BellRinger's charge unless I can prove that the charge does not accurately reflect the total amount of the outstanding balance I owe to satisfy my minimum fundraising commitment. In the event that I believe I can prove that BellRinger's charge to my credit card does not accurately reflect the total amount of the outstanding balance that I owe to satisfy my minimum fundraising commitment, I agree that I will speak to a BellRinger representative before I initiate any formal activity to dispute or cancel BellRinger's charge through my credit card company or bank.

I also agree to keep valid and effective credit card information on file at all times after I register for BellRinger and I will promptly respond to BellRinger's request to update my credit card information if necessary. I agree that, even if I fail to keep valid and effective credit card information on file, I am still obligated to satisfy the total amount of my minimum fundraising commitment if there is an outstanding balance after the fundraising deadline has passed and I will promptly respond to BellRinger's request to

satisfy any such outstanding balance. I further agree that a Rider registration fee must be paid before my registration for BellRinger as a Rider will be accepted and I understand that the Rider registration fee is not refundable or transferable even if I do not or cannot ride or participate in BellRinger for any reason whatsoever, including any illness or injury that may preclude my participation. I further understand and agree that the registration fee is not tax deductible and does not count toward my minimum fundraising commitment.

RULES OF PARTICIPATION

CANCELLATIONS

I agree that by registering as a Rider or Virtual Rider in BellRinger, I am obligated to satisfy the total amount of the minimum fundraising commitment for the particular route or participation option for which I am registered, as described in this Fundraising Agreement. I acknowledge if I voluntarily elect to become a Royal Ringer, I am obligated to satisfy the total amount of the minimum fundraising commitment for Royal Ringers as described in this Fundraising Agreement. I acknowledge and agree that I am entitled to cancel my participation as a Rider or Virtual Rider in BellRinger up to but not later than 11:59 p.m. on Thursday, September 21, 2023, and if I validly and effectively cancel my participation as a Rider or Virtual Rider by talking to a BellRinger representative before 11:59 p.m. on Thursday, September 21, 2023, I will not be responsible for satisfying the total amount of the minimum fundraising commitment for the particular route or participation option for which I had previously registered. However, I agree that, even if I cancel my participation as a Rider in BellRinger, my Rider registration fee is not refundable or transferable. If I cancel my participation as a Rider or Virtual Rider in BellRinger, the funds that I have raised as of the date of my cancellation as well as any funds that I raise on or after the date of my cancellation are not refundable to me or my donors. I further agree that, if I do not validly and effectively cancel my participation as a Rider or Virtual Rider in BellRinger by 11:59 p.m. on Thursday, September 21, 2023, or if I register as a Rider or Virtual Rider after 11:59 p.m. on Thursday, September 21, 2023, I am irrevocably obligated to satisfy the total amount of the minimum fundraising commitment for the particular route or participation option for which I am registered as described in this Fundraising Agreement, even if I do not or cannot ride in BellRinger for any reason whatsoever or cannot participate in my own Virtual Rider activities, including any illness or injury that may limit or preclude my participation.

ROUTE AND PARTICIPATION CHANGES

I agree that, by registering as a Rider or Virtual Rider in BellRinger, I am obligated to satisfy the total amount of the minimum fundraising commitment for the particular route or participation option for which I am registered, as described in this Fundraising Agreement. I acknowledge and agree that I am entitled to freely change my minimum fundraising commitment up to but not later than 11:59 p.m. on Thursday, September 21, 2023. I further acknowledge and agree that, after 11:59 p.m. on Thursday, September 21, 2023, I am not allowed to decrease my minimum fundraising commitment below the amount that I am committed to raise as of 11:59 p.m. on Thursday, September 21, 2023, and I agree that I am responsible for satisfying the total amount of the minimum fundraising commitment for the particular route or participation option for which I am registered as of 11:59 p.m. on Thursday, September 21, 2023, unless I voluntarily choose to increase my total minimum fundraising commitment. I further acknowledge and agree that, after 11:59 p.m. on Thursday, September 21, 2023, I am not allowed to cancel my participation as a Royal Ringer. I further acknowledge and agree that, while I am not allowed to decrease my minimum fundraising commitment after 11:59 p.m. on Thursday, September 21, 2023, I am allowed to increase my minimum fundraising commitment after 11:59 p.m. on Thursday, September 21, 2023. Furthermore, I acknowledge and agree that if I increase my minimum fundraising commitment after 11:59 p.m. on Thursday, September 21, 2023, I am not allowed to decrease my minimum fundraising commitment thereafter. I also agree that I am irrevocably obligated to satisfy the total amount of the minimum fundraising commitment for the particular route or participation option for which I am registered as described in this Fundraising Agreement, even if I do not or cannot ride the route for which I am registered for any reason whatsoever, including any illness or injury that may limit or preclude my participation. I further agree that, even if I decrease my minimum fundraising commitment before 11:59 p.m.

on Thursday, September 21, 2023, the funds that I have raised as of the date on which I make the change as well as any funds that I raise on or after the date on which I make the change are not refundable to me or my donors.

NO SUBSTITUTION POLICY

I understand and agree that my registration as a Rider or Virtual Rider in BellRinger is never transferable, even if I do not or cannot participate in BellRinger for any reason whatsoever, including any illness or injury that may limit or preclude my participation. I understand and agree that I am not permitted to grant another person the right to ride in BellRinger in my place under any circumstances.

COVID-19 RELATED CHANGES

BellRinger may be forced to cancel, reschedule, or modify the event based on guidance from local and federal public health officials in light of the public health risks posed by COVID-19. In the event of any such cancellation, rescheduling, or modification, BellRinger commits to reviewing and modifying Rider fundraising commitments to support its Riders' ongoing experience and relationship with BellRinger, and reserves the right, but shall not be obligated, to defer any amounts raised towards a Rider's fundraising commitment to a future iteration of the event.

I HAVE CAREFULLY READ THE FUNDRAISING AND PARTICIPATION AGREEMENT SET FORTH ABOVE. I FULLY UNDERSTAND THE TERMS OF THE FUNDRAISING AND PARTICIPATION AGREEMENT. I AM AWARE THAT BY SIGNING THIS FUNDRAISING AND PARTICIPATION AGREEMENT OR BY SELECTING THE "I ACCEPT" BUTTON DURING THE ONLINE REGISTRATION PROCESS, I AM AGREEING TO ALL OF THE TERMS OF THE FUNDRAISING AND PARTICIPATION AGREEMENT. KNOWING ALL OF THIS, I AGREE TO THE FUNDRAISING AND PARTICIPATION AGREEMENT IN ITS ENTIRETY FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT.
